Service providers will be limited to a maximum of **five commodities**, while General Trading category is discouraged. Commodities to select will be found on the database forms.

Applications without the relevant requested information will be disqualified. Any service provider whose name appears on the National Treasury Database as a person/entity prohibited from doing business with the public sector will be disqualified.
